MATRIX® LC CALCIUM SULFONATE GREASE

Matrix[®] LC is a heavy-duty addition to the Whitmore line of extreme pressure greases. This grease answers demands for a calcium sulfonate complex grease that is pumpable in cold weather and is suitable for higher speed bearings.

When formulating Matrix[®] LC, Whitmore chemists started with Matrix[®] EP, which has been our flagship grease for several years. Several changes were made, including the use of a new polymer. All of the most notable benefits of Matrix[®] EP were retained in Matrix[®] LC including long life, outstanding wear protection, and excellent water resistance. Needless to say, the rust protection afforded by the calcium sulfonate thickener remains.

All grades of Matrix[®] LC contain SL-Tech[™], a proprietary solid lubricant that has been proven to provide outstanding extreme pressure protection. Matrix[®] 5M LC 2 also contains additional protection in the form of 5% molybdenum disulfide, making it ideal for bearings on heavily loaded equipment such as Draglines, Electric Shovels, Hydraulic Shovels, earthmoving equipment, etc.

- SEALING EFFECT keeps water from entering the bearing.

APPLICATIONS:

Besides electric motor bearings, Matrix® LC is recommended for use in bearings exposed to water, including water that is alkaline or acidic. It may also be used in applications where re-lubrication is infrequent.

This grease is suitable for highly loaded applications such as Draglines, Electric Shovels, Steel Mill Roll Stands and slew ring bearings on hydraulic Shovels.

Matrix® LC 1 is recommended for single-point and centralized lubrication systems such as Lincoln, Graco, Farval, Vogel, etc.
